a. Discussion of Non-Profit Status

The Board was advised that our CPA has filed the necessary documents with the IRS. However, they did require changes in our Constitution and policies to ensure acceptance.

b. Review of proposed revision to Constitution

A new section was proposed for the constitution:

Sec. 20. DISSOLUTION: Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Was discussed as being necessary to meet IRS expectations of our non-profit organization. Dallas Conor made the motion to accept revision, Tiffany Hayes seconded. The motion carried.

c. Review proposed Conflict of Interest Policy

A new policy that address conflict of interest of any board member or officer of the board was proposed to also meet IRS expectations for our non-profit status. Dallas Conor made the motion to accept revision, Michelle Combs seconded. The motion carried.

1) As Secretary Treasurer, Dallas Connor signed the <u>Certificate of Adoption of Conflict of Interest clause</u>.

6. New Business

a. Discuss Constitutional Amendment

The Board was asked to consider an amendment to the Constitution that formalized a mechanism to allow officers after the first six months from commissioning to join the Association. Dallas Connor made the motion:

"To become a member of this Association the applicant must be a bona fide member of the Fort Worth Police Department, and make application for membership. Applications made within five years after commissioning, shall not be required to "catch up" dues. NO financial assistance may be paid, within the first six months after a member's application is approved, unless agreed upon by a majority of the full Board of Directors.

Further, applications made after five years from commission date, shall be required to "catch up" dues at an amount determined by the Board of Directors, not to exceed \$500.00

NO financial assistance may be paid, within the first year after a member's application is approved, unless agreed upon by a majority of the full Board of Directors."

Tiffany Hayes seconded the motion and the motion passed.
