  - 1) Financial Assistance and Death Benefit Trends

A decision was made in the December 2023 Board of Directors meeting to present a potential dues increase from \$6 to either \$8 or \$10.

After some discussion regarding the services provided and continued increased costs, a motion was made to "Increase dues \$2 effective April1, 2024. The board will revisit additional dues increases in future general membership meetings. Dallas Connor made this motion and Michelle Combs seconded. The motion carried.

b. Discuss Secretary- Treasurer's monthly allowance increase The current monthly allowance is \$300. When the board president supervised the current secretary-treasurer he could attest to the amount of work this position required. General members stated they concurred with an increase raise and knowing that the secretary-treasurer uses her personal vehicle to provide services the motion was made "Raise the allowance to \$500 per month."
